Booking Terms, Conditions and Liabilities:

This forms a binding contract between the Renter as listed above and Confederation Homestead (also called “the cottage”), owned and operated by Jean-Marie Barker and David Archer. The maximum number of renters allowed is 6 and the complete names, addresses and ages of those staying at the cottage are listed above. This maximum is given due to septic limitations. No additional guests will be permitted. The number of day visitors and registered guests shall not exceed 6.

This is a housekeeping cottage and you are expected to leave the cottage in the same condition as you found it, in a condition that you would expect to find it. There will be no subletting of the cottage property permitted. A separate application must be made for separate parties. There shall be no camping, tenting or otherwise placing of auxiliary accommodation facilities on the property without prior authorization.

The cottage has contracted lawn care and snow removal and the renter is advised that these services may be performed during your stay, however these contractors are aware the property is rented and they will be respectful of your use of the property.

Deposit and payment:

Only Electronic payment is accepted. A deposit of 50% of the rental will be required and the balance due 4 weeks before the rental. If it is less than 4 weeks before the rental, the full amount will be due.

Our preferred payment method is bank e-transfer. You may also pay by PayPal, which accepts Debit and Credit, but there is a surcharge to use that method. Please advise your preferred payment method.

Our standard bank e-transfer question is “Where is the cottage located?” Answer: “Minden”.

If you choose PayPal, we will send an invoice and advise you of the surcharge.

Security deposit:

You will either provide a security deposit cheque in the amount of \$600. made payable to Jean-Marie Barker, or you will provide your Visa or Mastercard number with expiry date, for a security deposit. The cheque will be returned to you after your rental if there are no extraordinary expenses associated with your stay. By signing this document you agree that if there are any damages, missing items or extra cleaning required, you authorize us to charge your credit card up to a maximum of \$600.

Further I/we accept full responsibility for the use of any recreational equipment, etc. provided and agree to pay for any repairs or replacement of said equipment other than for normal wear and tear. You also agree that the references given may be checked by us.

Booking and Cancellation Policies:

A rental reservation is not final until the completed application has been returned, accepted by us and the required deposit (or full rental if less than 30 days) is paid. We allow up to 2 days for this deposit to reach us once your application has been accepted. If payment is not made within 2 days, we cannot guarantee your reservation and that time period will be open to other renters. If the rental period is more than 30 days away, the balance is due 30 days before the rental.

If you request us to hold a reservation time, we will allow 24 hours after which, if not confirmed, it may be released to other potentially interested parties.

If you wish to cancel your reservation after your deposit has been made but 60 days before your rental, and we are able to re-book the full time, your deposit will be returned, less 50% administration fee. If we cannot re-book then the entire deposit will be forfeited. If you cancel 30 days or less before the rental, and the full payment has been made, if we cannot re-book then the full amount will be forfeited.

If we can re-book, then 50% of the full payment will be refunded. If the cancellation is due to serious illness, accident or death in the family, please advise us as we are flexible and we will try to re-book your time at a future date.
